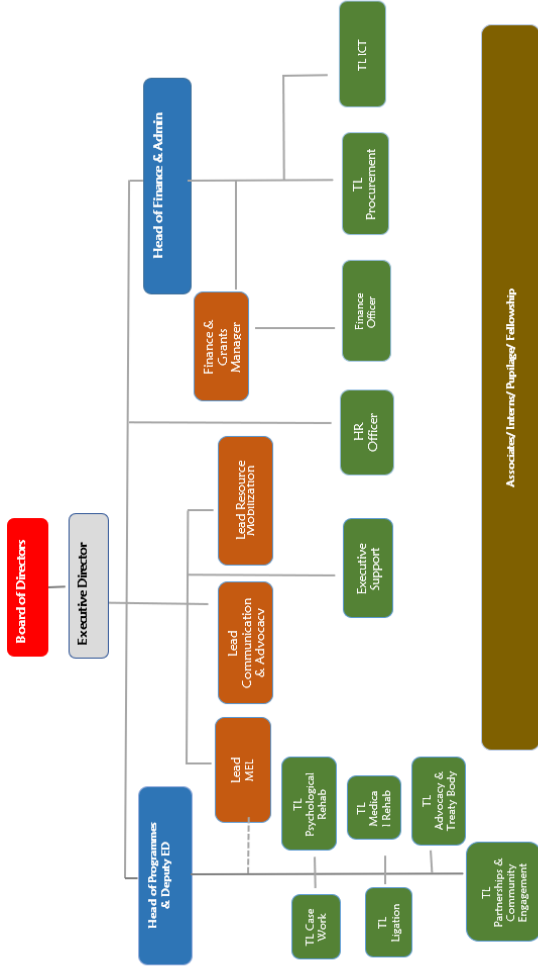

## WHAT WE DO

At IMLU, we are deeply committed to advancing human rights and ensuring justice. Here's how we are making a difference:

**1. Forensic documentation:** Providing evidence-based factual documentation that enables justice and healing for survivors.

**2. Rehabilitation:** Providing holistic support, including medical and psychosocial services, to help survivors heal and reintegrate into society.

**3. Litigation:** Engaging in legal actions to hold perpetrators accountable and seek justice for victims of torture and related violations.

**4. Advocacy:** Promoting policy and legal reforms to prevent torture, and sexual violence, and improve the protection of human rights.

**5. Capacity Building:** Strengthening the capacity of state agencies and civil society organizations to



respond effectively to torture, sexual violence, and related human rights violations cases.

**6. Monitoring and Reporting:** Monitoring and reporting on government adherence to international, regional, and national human rights commitments.

**7. Research:** Conducting strategic research to inform advocacy efforts and promote evidence-based interventions.

## OUR IMPACT

For over 30 years, IMLU has been at the forefront of advancing human rights in Kenya. Our forensic documentation provides fact-based evidence that supports legal accountability, fosters healing, and seeks reparations for victims. As an organization with United Nations Economic and Social Council (ECOSOC) Special Consultative Status and African Commission on Human and Peoples'

Rights (ACHPR) Observer Status #450, we continually monitor the Kenyan government's adherence to international, regional, and national human rights commitments. By submitting reports to these mechanisms, we ensure accountability and advocate for meaningful reforms to uphold and protect human rights.

- 6,000+ survivors supported through legal, medical, and psychological assistance.

Rehabilitation success stories: Helped thousands of survivors heal, reintegrate into society, and rebuild their lives.

- 300+ successful legal cases against perpetrators of torture, ensuring justice for victims.

Secured justice for 300+ victims of torture, including survivors of sexual violence, holding perpetrators accountable and setting legal precedents.

- 2 laws enacted. The Prevention of Torture Act (POTA) 2017, The National Coroners' Service Act (NCSA). Advocacy efforts led to key laws improving human rights protection in Kenya.

#### **Prevention of Torture Act (POTA) 2017**

Domesticates the United Nations Convention Against Torture.  
Provides for state officers to be held accountable for acts of torture.

#### **National Coroners Service Act (NCSA) 2017**

Provides for thorough investigation of cases of extrajudicial killings and enforced disappearances.

- Capacity building: Trained hundreds of journalists, morticians, investigators, doctors, and other professionals, equipping them to respond effectively to torture, sexual violence, and related cases.
- 14 police stations supported
- 47 counties reached, benefiting 500,000+ indirectly.
